**AN UPDATE FROM ENO'S EXECUTIVE DIRECTOR** 

### Dear Friends.

Thank you for taking a few moments to read this edition of Eno River Currents; to celebrate with us our accomplishments of the past 17 or so months. This year has been flying by, so our newsletter is coming out a little later than usual and is doing double duty: the enclosed 2020 Annual Report reflects all we were able to accomplish during the pandemic, while other articles highlight



those areas where we have already exceeded our expectations for outreach and conservation in 2021.

What a SUMMER we have had! We have put away the Festival Big Top tent, wrapped up our third and final week of summer camp, honored outgoing Resilience Corps NC AmeriCorps staff member Antonia Brown, gone under contract on 110 acres to add to Eno River State Park, initiated the transfer of 8 acres to add to West Point on the Eno Durham City Park, and are underway on a 70acre conservation easement in Orange County on the historic Moorefields property. That's not to mention our winter and spring successes: over 200 of you joined us for Bing-ENO, our winter & spring hike series served 112 individuals, and our new hiker series served more than two dozen folks new to the Eno!

I hope you were one of the approximately 8,500 guests at our Festival for the Eno this July 3 & 4th. It was truly a beautiful and heartwarming sight to see you skip into the park, hug your friends, sip lemonade, splash in the Eno, and dance to the variety of musical performers. Putting on the Festival with just two months' notice was a grand reminder of what the Eno community can do because of YOU. Your support through giving, volunteering, and championing the Eno means the world to us. We couldn't have pulled off the 2021 Festival without you; we couldn't have gotten through 2020 without you. And now we look forward to many more years together with you. Onward!

One of the first things Greg Bell said to me was, "We couldn't do this without our volunteers." At the time I had NO idea of the magnitude of that statement. When I got a look at the volunteer portal (with its word salad of 61 job descriptions, 350 shifts. and 670 spots), I wondered what I had gotten myself into.

Spanning from June 26 through July 6, 470 individual people contributed their time and energy to make the Festival for the Eno happen. From erecting the Big Top to selling drinks and t-shirts to manning the ticket booths to cleaning up the trash, volunteers worked over 2000 hours. Add in the behindthe-scenes volunteers (committee members, site personnel, money

I currently serve on the Eno Finance, Land Use and Advocacy, and Strategic Planning committees.

handlers) who worked for months before and after the event. and we had over 500 volunteers touching every aspect of the Festival. We could not do this without our volunteers.

But the numbers aren't a true representation of the benefits we get from volunteers. Our volunteers recruit their successors. They recruit friends and family. They train first-time



volunteers. They train first-time staff! They propose and implement new ideas. They manage the stages. They chronicle the Festival. They talk about the Eno. They ease the burden on staff. They get us from 61 jobs, 350 shifts, 470 individuals, 670 spots, and 2000 hours to a Festival. And they come back, year after year after year. We could NOT do this without our volunteers.

# **HISTORY IN THE MAKING**

In 1972 the Eno River Association formed an alliance with the Nature Conservancy and presented to the North Carolina Board of Conservation and Development their case for preserving the Eno River. As a result, the Board of the Nature Conservancy and its State Parks Committee endorsed acquiring property along the river for a state park. Through a cooperative effort between the City of Durham, Orange County, the State of North Carolina, the Nature Conservancy, and the Eno River Association, on June 15, 1973, Governor James Holshouser welcomed the Eno River State Park into the NC State Parks system. The Association's relationship with Eno River State Park has continued since that historical accomplishment. The Association's efforts over the years have grown Eno River State Park into a 4,500-acre public amenity through numerous land protection projects.

The Association was also instrumental in the creation of another public park: the City of Durham's West Point on the Eno, which has preserved natural and cultural features along a two-mile stretch of the Eno River adjacent to Eno River State Park. In fact, one of the first parcels the Association helped protect was for West Point on the Eno City Park.

To address the recent growth in the use and enjoyment of our natural spaces, the Eno River Association is thrilled to announce that we are adding 110 acres to Eno River State Park and 8 acres to West Point on the Eno! The 110 acres being added to Eno River State Park will expand the northernmost extent of the park and provide protection to over 4,500 linear feet of tributaries of the Eno River. This land is a priority acquisition in the State Park's Master Plan and thus represents a top priority for the Association. Similarly, the Association is donating 8 acres of land located off Landis Drive to the City of Durham for inclusion into West Point on the Eno.

The addition of nearly 120 acres to these parks comes on the heels of record-setting crowds in our parks and natural areas. 2020 demonstrated that accessible outdoor spaces are vital to the physical and mental health of our community. The growth of these parks will allow more space for visitors to

recreate, seek solace, and enjoy the beauty of nature while also providing safe and accessible wildlife habitat, protecting water quality, and improving air quality in the face of a tremendous amount of development pressure in our watershed.





**2021 CAMPS** 

After making the difficult decision to cancel iWalk the Eno Science and Nature Camp in 2020 due to the COVID-19 pandemic, we were ecstatic to be able to offer it once again this June. Following guidance from the CDC and NCDHHS, we limited capacity, required masks and social distancing, and increased hand washing and disinfection of surfaces between activities. Despite the challenges posed, we held a successful two weeks of nature exploration and fun with 80 campers at Eno River State Park and West Point on the Eno City Park. Our NC certified teachers and student mentors facilitated a variety of fun and educational activities along the river. Favorite activities this year included designing and building mini beaver dam replicas, cane pole fishing with Durham Parks and Recreation staff, and a stewardship project with the State Park Rangers.

In mid-July of this year, we spent a week at the Confluence Natural Area in Hillsborough with a group of 30 high school students at Eno River Field Station. This program invites students who have a passion for the sciences and may be considering a career in a STEM-related field for a week of field study and research with career professionals. Our NC certified teacher group leaders and guest educators from local organizations, including NC State Parks, Duke University, and NC Wildlife Resources Commission, led the groups in field study projects throughout the Confluence Natural Area. Favorite subjects this year included hummingbird banding, herpetology, fish surveys, and bat banding.

# **AMERICORPS UPDATES**

On July 31st, we said goodbye to our Resilience Corps NC AmeriCorps member, Antonia Brown. Antonia served as an Environmental Educator for the Association and joined us in September 2020, a challenging time to begin a new position. She jumped right in though, assisting with facilitation of virtual programs, filming and presenting various Eno YouTube educational videos, and becoming an integral member of our Environmental Justice, Diversity, Equity & Inclusion committee.

Antonia was the first of three AmeriCorps members the Eno River Association will have as a part of the team over the next three years. She has helped lay the groundwork for our future Members who will be tasked with increasing our capacity to reach our underserved communities within and nearby the Eno River watershed. She will be missed greatly! We look forward to introducing you to our incoming AmeriCorps Environmental Educator Audrey Vaughn!

# **EXPANDING UPON SCHOOL FIELD TRIPS**

As summer comes to a close, we are looking forward to the cooler months and the education and outreach opportunities they present. This summer we were awarded a \$48,000 grant from the City of Durham through the Participatory Budget Cycle 2. Durham city residents had the opportunity to vote on their favorite grant proposals for up to \$50,000 in funding. Out of 60 applicants, proposals were narrowed down to 31 and voted on during the month of June. The Eno River Association is among those who won the vote and were awarded funding through this program. This funding will help us to increase our outreach to local public schools, particularly Title One Schools, who were among those most affected by the pandemic. Our aim is to lower barriers that dissuade schools from participating in field trips and other educational opportunities in the community. We will be inviting public schools in Durham to learn about and explore the Eno River through field trips and other educational opportunities at little to no cost to them.
